The undersigned incorporator, in order to form a corporate entity in compliance with Chapter 607 and/or Chapter 621 of the Florida Statutes (Profit), adopts the following articles of incorporation.

ARTICLE I – NAME

The name of the corporation shall be: Humble Hands Services, Inc.

ARTICLE II – PRINCIPAL OFFICE

ARTICLE III – PURPOSE
