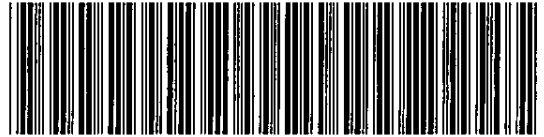



In compliance with the requirements of F.S. Chapter 607 and 621, the undersigned hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation. The existence of this corporation shall be perpetual.

**ARTICLE I**

The name of the Corporation is: The Law Office of Christi Daisey, P.A..

**ARTICLE II**

The existence of the Corporation shall begin on: February 12, 2008.

**ARTICLE III**
