Article I. NAME AND LOCATION OF PRINCIPAL OFFICE

The name of this corporation is COVERDALE & ASSOCIATES, INC. and the principal office of said corporation is as follows: 5841 Estes Lane, Zephyrhills, FL 33545

Article II. OBJECTS AND PURPOSES

The objects and purposes for which this corporation is formed are:

To conduct and transact generally the business of a corporation and to do all things and exercise all powers and perform all functions that a corporation is authorized or empowered to do, exercise, or perform under and by virtue of the laws of Florida, or that it may be by law hereafter authorized to do, exercise, or perform, and to do all the above things as corporation and insofar as is consistent with the laws of Florida.

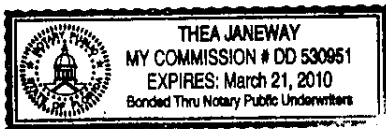
