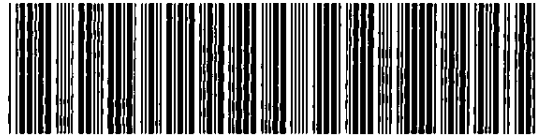

Article I – Name





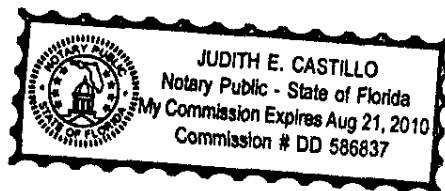
