**ARTICLES OF INCORPORATION
OF
TODD B. HEIMOWITZ, D.O., P.A.**

The undersigned, a natural person competent to contract and a physician duly licensed under the laws of the State of Florida, does make, subscribe and file these Articles of Incorporation for the purpose of organizing a professional service corporation under the Professional Service Corporation and Limited Liability Company Act and other applicable laws of the State of Florida.

**ARTICLE I
CORPORATE NAME**

The name of this professional service corporation shall be: TODD B. HEIMOWITZ, D.O., P.A.

**ARTICLE II
NATURE OF CORPORATE BUSINESS**

The general nature of the business to be transacted by this professional service corporation shall be:

A. To engage in every aspect and phase of the practice of rendering the same professional services to the public that physicians, duly licensed under the laws of the State of Florida, are authorized to render, provided, however, that such professional services shall be rendered only through officers, employees and agents of this professional service corporation who are duly licensed as physicians under the laws of the State of Florida.




