ARTICLE I NAME

The name of the corporation is **CULTURE AND THRILLS, INC.** ("Corporation"). The address of the Corporation is **3903 Moran Road, Tampa, Florida 33618**.

ARTICLE II DURATION

The Corporation shall have perpetual existence.

ARTICLE III PURPOSE
