ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is Zom-Alston, Inc. Its principal office address and business mailing address is 8620 Northwest 48th Street, Fort Lauderdale, Florida 33351.

The Corporation shall have a perpetual existence.

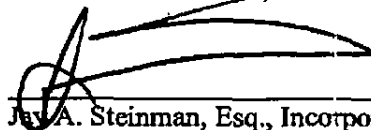
