ARTICLES OF INCORPORATION OF

The undersigned Incorporator, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation is Inktel Direct Government BPO Services, Inc.

ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the corporation's principal office and the corporation's matting attress are 13975 N.W. 58th Court, Miami Lakes, Florida 33014.

ARTICLE III. DURATION AND COMMENCEMENT

OF CORPORATE EXISTENCE

The corporation shall exist perpetually. The corporate existence shall commence pon the filing of these Articles of Incorporation with the Department of State.
