The undersigned Incorporator, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation is **Inktel Direct Government BPO Services, Inc.**

ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS

**ARTICLE III. DURATION AND COMMENCEMENT
OF CORPORATE EXISTENCE**
