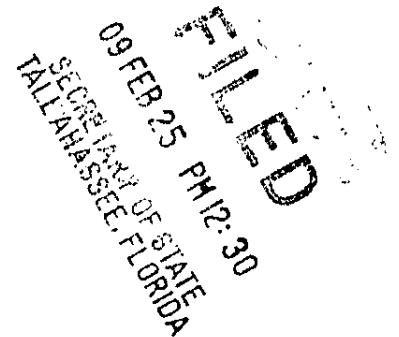

**ARTICLES OF INCORPORATION
OF

The undersigned incorporator, MICHEL J. BRETON, a natural person competent to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

ARTICLE I - NAME

The name of this corporation is BRETON CONSTRUCTION, INC.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE
