**ARTICLES OF INCORPORATION
OF

The undersigned, pursuant to the provisions of Chapters 607 of the Florida Statutes, for the purpose of forming a corporation under the laws of the State of Florida set forth the following:

ARTICLE I - NAME

The name of the Corporation is The Filling Station Corp.

ARTICLE III - DURATION

The Corporation shall have a perpetual existence.
