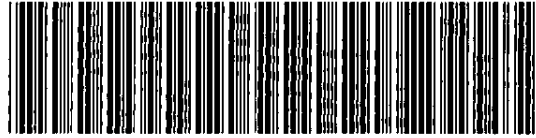

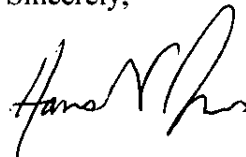

**ARTICLES OF INCORPORATION**

**OF**

**THE UNDERSIGNED**, acting as sole incorporator of Zip Spring, Inc., under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I**

**Name and Office**
