**AMENDED AND RESTATED
ARTICLES OF INCORPORATION
OF
THE SITE 4 SIGHT, INC.**

The undersigned, Jason Jacob, being a duly elected President of THE SITE 4 SIGHT, INC., a Florida corporation (the "Corporation"), hereby states as follows on behalf of the Corporation:

1. The Articles of Incorporation of the Corporation (the "Articles", as amended from time to time) were filed with the Secretary of State of the State of Florida on March 2, 2009 under Document Number P09000019329, and further amended on May 28, 2009.

2. Pursuant to the requirements of Sections 607.1006 and 607.1007 of the Florida Business Corporation Act, the undersigned hereby certifies, attests and serves notice that the Articles of the Corporation are hereby amended and restated in their entirety to read as follows, which Amended and Restated Articles of Incorporation incorporate all amendments to all articles of the Articles of Corporation:

ARTICLE I - NAME

The name of this corporation is THE SITE 4 SIGHT, INC. (the "Corporation").

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS
