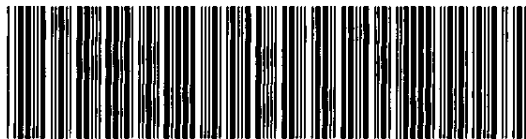

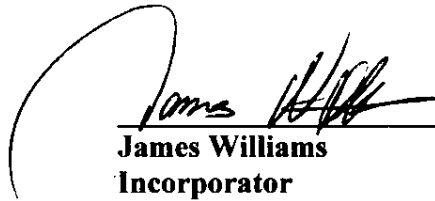
ARTICLE NINE
