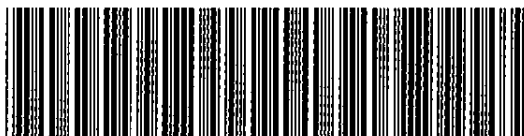

We, the undersigned incorporators, hereby associate ourselves together and make, subscribe, acknowledge and file with the Secretary of State of Florida these Articles of Incorporation for the purpose of forming a Corporation for profit in accordance with the laws of the State of Florida.

**ARTICLE I - NAME**      Effective Date *Feb. 25, 2009*

The name of this Corporation is DOCTORS MEDICAL CARE, INC.

**ARTICLE II - DURATION**

This Corporation shall have perpetual existence commencing on the 25th day of February, 2009.

**ARTICLE III - PURPOSE**

The purpose of this Corporation is to transact any or all lawful business for which Corporations may be incorporated under Chapter 607, Florida Statutes, as now exists or may after be amended.

**ARTICLE IV - CAPITAL STOCK**

This Corporation is authorized to issue 300 shares of One Dollar (\$1.00) par value common stock which shall be designated as "Common Shares".

## **ARTICLE V - PRE-EMPTIVE RIGHTS**

## **ARTICLE IX - INDEMNIFICATION**


The Corporation shall indemnify any Officer or Director or any former officer or director, to the

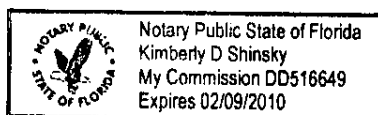




