

The undersigned subscriber(s) to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves to form a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation is: Quantum Uniforms Inc.

The general nature of the business and the objects and purposes to be transacted and carried on is the provision of security services and to carry on any other business whatsoever in connection with the forgoing or which is calculated directly or indirectly, to promote the interest of the corporation or to enhance the value of its properties.


