

ARTICLES OF INCORPORATION OF:

AQUABALANCE SERVICES, CORP.

The undersigned subscriber to these Articles of Incorporation is a Natural Person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE I - NAME

The name of this corporation is AQUABALANCE SERVICES, CORP.

ARTICLE II - DURATION / TERM OF EXISTENCE

These articles of Incorporation may be amended in the manner provided by law.
