**ARTICLES OF INCORPORATION
OF

ARTICLE I
NAME

The name of the corporation is: RONALD DEVOE LAWN SERVICES, INC. at
912 NW 2 St., Ft. Lauderdale, FL 33311.

ARTICLE II
DURATION

This corporation shall have perpetual existence.

ARTICLE III
PURPOSE

This corporation is organized for the purpose of transacting any or all lawful
business.

ARTICLE IV
CAPITAL STOCK

This corporation is authorized to issue Five Thousand shares of One Dollar par
