4. To carry on any other business or enterprise which may be carried on or exercised by a corporation organized under Chapter 607. Florida Statutes, as amended, except a banking, safe deposit, trust, insurance, surety, express, reitroad, canai, telephone, telegraph or cemetery company, a building and loan association, fraternal benefit society, state fair or exposition.

### ARTICLE III

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 500 shares of common stock have a par value of \$1.00.

This corporation shall have perpetual existence.


