## ARTICLES OF INCORPORATION of BARN ENTERPRISE, INC.

The undersigned hereby makes, subscribes, acknowledges, and files with the Secretary of State of the Secretary of Secretary of State of the Secretary of Secretar

ARTICLE I Name

The name of this corporation shall be BARN ENTERPRISE, INC.

ARTICLE II
Term of Existence and Fiscal Year

This corporation shall begin existence on the date of filing of these articles with the Secretary of State of the state of Florida, and shall have perpetual existence thereafter. This corporation shall have a fiscal year beginning January 1st of each year.

ARTICLE III
Nature of Business

The general nature of the business to be transacted by this corporation shall be lawful, and the objects and purposes thereof, shall include real estate investing.

ARTICLE IV Powers

This corporation shall have all powers conferred by the laws of the state of Florida on corporations.

ARTICLE V Capital Stock

This corporation is authorized to issue 1000 thousand (1000) shares of common voting stock. - (c) No holder of any class of stock of this corporation shall have any preemptive or preferential right to subscribe to, purchase, or receive any shares of any class of stock of the corporation, whether now or hereafter authorized, or any notes, debentures, bonds, or other securities convertible into or carrying options or warrants to purchase shares of any class of stock of the corporation issued or sold or proposed to be issued or sold or with respect to which options or warrants shall be granted; but all these shares of stock of any class or notes, debentures, bonds, or other securities convertible into or carrying options or warrants to purchase shares of any class may be issued and disposed of or sold by the board of directors on terms and for consideration, as far as may be permitted by law, and to any person or persons who are qualified to be shareholders as the board of directors may determine.

## ARTICLE VII Initial Registered Office and Agent

## ARTICLE VIII Principal Place of Business
