

I, the undersigned, in order to form a corporation for the purpose hereinafter stated, under and pursuant to the provisions of the Several Acts of Legislature of the State of Florida, do hereby subscribe to these Articles of Incorporation:

**ARTICLE I**

The name of the corporation is; **DUDY PRODUCE, INC**

**ARTICLE II**

The general nature of the business to be transacted by this corporation is to engage in the business of produce sales, as well as other business permitted under the laws of the United States and the State of Florida.

To conduct debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness and execute such mortgages, transfers or corporate property, or other instruments to secure the payment of corporate indebtedness as required.

To purchase the corporate assets of any other corporation and engage in the same or other character of business.
