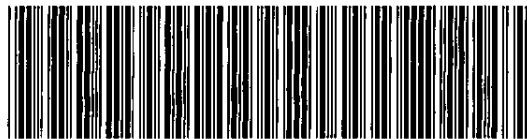

**ARTICLES OF INCORPORATION**  
**FOR**  
**RAPID CAPITAL CORP.**

The undersigned, acting as incorporator under the Florida Business Corporation Act, adopts the following Articles of Incorporation for RAPID CAPITAL CORP.

1. The name of the corporation is RAPID CAPITAL CORP.
2. The principal office address of the corporation is 1801 N. Military Trail, Suite 203, Boca Raton, Florida 33431.

4. The corporation shall have authority to issue 10,000.00 shares of stock, all of one class with a par value of \$.01 per share.

10. The Board of Directors of this Corporation is expressly authorized to adopt, amend or repeal the Bylaws of this Corporation, or any provision thereof.

11. The Corporation shall, to the fullest extent permitted by the laws of the State of Florida including, but not limited to, Section 607.0850 of the Florida Business Corporation Act, as the same may be amended and supplemented from time to time, have the power to indemnify any and all directors, officers and agents of the Corporation.

12. This Corporation expressly elects not to be governed by Section 607.0902 of the Florida Business Corporation Act, as amended from time to time, relating to control share acquisitions.

13. This Corporation expressly elects not to be governed by Section 607.0901 of the Florida Business Corporation Act, as amended from time to time, relating to affiliated transactions.

14. The effective date of the corporate existence pursuant to section 607.0203 of the Florida Statutes shall be March 4, 2009, provided such date is within five (5) business days prior to the date of filing.
