The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

## ARTICLE I: NAME

The name of the Corporation is Carol Tormey, PT, P.A. Principal place of business is 1555 South Ocean Lane, Apartment 274, Fort Lauderdale, Florida 33316.

#### ARTICLE II: DURATION

The existence of the Corporation shall commence with the filing of these Articles. The duration of the Corporation is perpetual.


