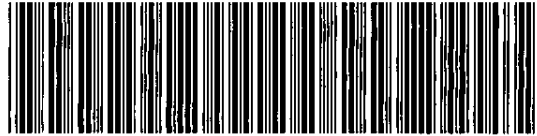

ARTICLE I – CORPORATE NAME
