ARTICLES OF INCORPORATION SEURETARY OF STATE TALLAHASSEE, FLORIDA

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation:

The name of the corporation is S S Health Care Corp.


