



ARTICLES OF INCORPORATION

OF

TRUE HUE, INC.

The undersigned, acting as subscriber of a corporation under the Florida Corporation Law, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

NAME

The name of the corporation is TRUE HUE, INC..

ARTICLE II

DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

PURPOSE
