**ARTICLES OF INCORPORATION
OF

The Undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the Corporation is: **Kawama Construction, Inc.**

ARTICLE II - ADDRESS OF THE PRINCIPAL OFFICE

Located in Hillsborough County, the principal place of business and street address of this corporation shall be: **4103 West Sevilla Street - Tampa, Florida 33629**

ARTICLE III - PURPOSE

The purpose of the corporation and the general nature of the business to be transacted shall be in construction and any other lawful business. The corporation shall make and enter into all contracts necessary and proper for the conduct of its business or businesses. In general, this corporation shall have and exercise all the powers conferred by the laws of the State of Florida upon corporations for profit.
