ARTICLES OF INCORPORATION OF G. M. TILE & ROOFING OF FLORIDA, INC.

The undersigned incorporator hereby executes and acknowledges these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I Name

ARTICLE III Business and Purposes
