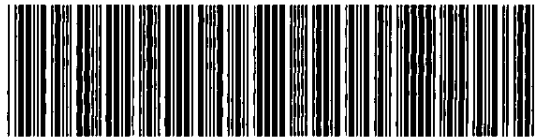

ARTICLES OF INCORPORATION
OF

ARTICLE I
CORPORATE NAME, PRINCIPAL OFFICE
AND MAILING ADDRESS

The name of this Corporation shall be: ***MobileCastLive, Inc.***, with its principal office located at 719 W. Winter Park Street, Orlando, Florida 32804 and its corporate mailing address being the same.



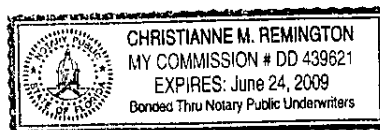
