The undersigned, incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act | Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation

ARTICLES II NAME OF THE CORPORATION

The name of the corporation is MZ. TRUKER'S MOBILE AUTO AND TRUCK DETAIL. INC., referred to as the "Corporation".
