## **ARTICLES OF INCORPORATION**

The undersigned Incorporator (s) for the purpose of forming a Corporation under the Florida Business Corporation Act, hereby adopt (s) the following Articles of Incorporation.

### **ARTICLE I NAME**

The name of the corporation shall be: **BP International Trading** Corp.

### ARTICLE II NATURE OF BUSINESS

The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida: This includes commercialization, buy, sell, trade, import, export, and distribute parts, electronics, machines and equipment, aircraft parts and components among others. The company will also act as purchasing agent for goods, services, merchandise and/or other consideration, whether issued directly or through or in combination with third parties, domestic or foreign. The Company will also act as intermediary and payment processor.

### ARTICLE III CAPITAL STOCK

The corporation is authorized to have outstanding one class of stock designated as voting common stock. The maximum number of shares of common stock which the corporation is authorized to have outstanding is 1,000 shares of a par value of \$ 1.00 per share. Holders of common stock are entitled to one vote per share, and there shall be no cumulative voting. Holders of all common stock classes shall have preemptive rights to subscribe to the Corporation's securities.
