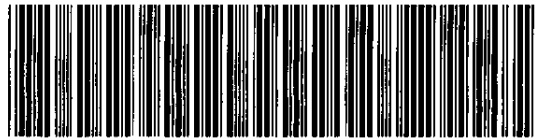

**ARTICLES OF INCORPORATION**

**Article I: NAME**

The name of the corporation is Saturday Enterprises, Inc.

**Article II: PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be 700 Sequoia Trail, Maitland, FL 32751.

**Article III: SHARES**

The aggregate number of shares that this corporation is authorized to issue is 5,000 shares of common stock having a par value of \$1.00 each, and such shall be designated "common shares."

**Article IV: INITIAL REGISTERED AGENT AND ADDRESS**

The name of the initial registered agent of this corporation is Carol A. Ratliff and the street address of the initial registered office of his corporation is 700 Sequoia Trail, Maitland, FL 32751.

**Article V: INCORPORATOR**

The name of the incorporator of this corporation is Carol A. Ratliff and the street address of the incorporator of this corporation is 700 Sequoia Trail, Maitland, FL 32751

## **Article VI: DURATION**

This corporation shall have perpetual existence, unless sooner dissolved according to law.

## **Article VII: PURPOSE**

This corporation is organized for the purpose of transacting any or all lawful business.

## **Article VIII: PRE-EMPTIVE RIGHTS**

Every shareholder, upon the sale (by this corporation) for cash or property of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price per share at which it is offered to others (based on cash value or fair market value of property involved in the sale.)

## **Article IX: BY-LAWS**

The power to adopt, alter, amend or repeal by-laws shall be vested in the Board of Directors and the shareholders.

## **Article X: Amendment**

This corporation reserves the right to amend or repeal any provisions contained in these articles of incorporation, or any amendments thereto, and any right conferred upon the shareholders is subject to this reservation.

## **Article XI: INITIAL BOARD OF DIRECTORS**

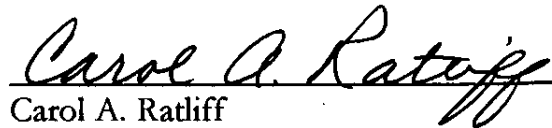

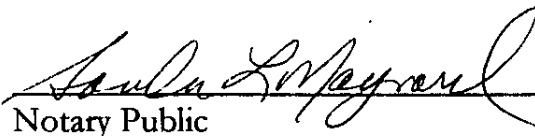

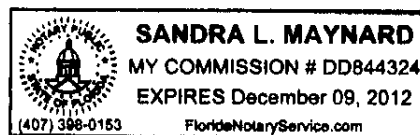
