ARTICLES OF INCORPORATION OF

SAFE HARBOUR FINANCIAL GROUP, INC.

I, the undersigned, hereby make the within Articles of Incorporation for the purpose of becoming incorporated and being a corporation under and by virtue of the laws of the State of Florida pertaining to the Florida Business Corporation Act, under the following proposed charter:

ARTICLE I - NAME/ADDRESS

The name of this corporation shall be **Safe Harbour Financial Group, Inc.**, and its business shall be carried on in the State of Florida connected with the aforesaid purpose. And in addition, to engage in any other business or businesses permitted under the laws of the United States and the State of Florida. and such other states and foreign countries as may be agreed upon, and it's principal place of business shall be 13970 W.
