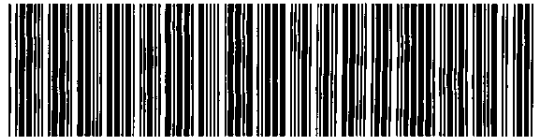

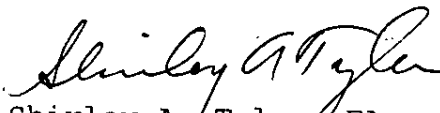

The undersigned subscriber to these Articles of Incorporation hereby forms a Corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be: MICHELLE & DAVE ULTIMATE CAR CARE, INC. The principal place of business will be 7424 4TH St. N., St. Petersburg, FL 33702-5408.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

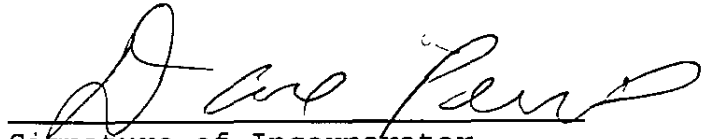
ARTICLE VIII - INCORPORATORS

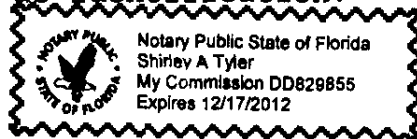

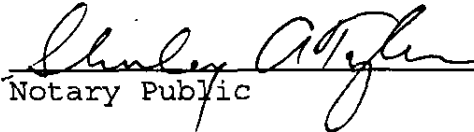

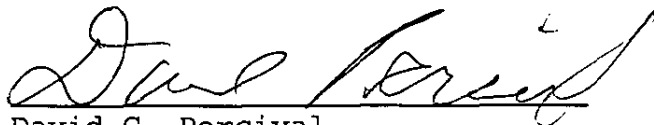
