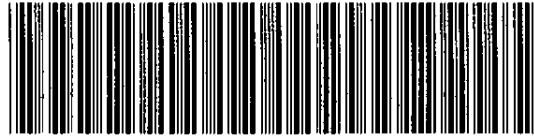




We, the undersigned, as all of the Directors of CLINICAL SKINCARE RESEARCH, INC., a corporation organized under the laws of the State of Florida, do hereby, for the purpose of compliance with the provisions of Section 607.1403, Florida Statutes, in relation to the voluntary dissolution of corporations, make and attest these Articles of Dissolution and certify as follows:

1. The name of the corporation is CLINICAL SKINCARE RESEARCH, INC.
2. All debts, obligations, and liabilities of the corporation have been paid or discharged.
3. No property remains for distribution to shareholders after applying it to the payment of the liabilities and obligations of the corporation.




NOTICE OF SHAREHOLDERS' RESOLUTION TO DISSOLVE CORPORATION


