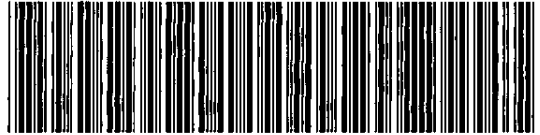

The Undersigned Subscriber to these Articles of Incorporation, a natural person competent to contract, for the purpose of forming a corporation under the Florida Corporation Law, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the Corporation is QUES PERSONNEL, INC.

ARTICLE II: DURATION

The existence of the Corporation shall commence with the filing of these Articles. The duration of the Corporation is perpetual.

ARTICLE III: PURPOSE

The Corporation may engage in the business of recruiting, brokering, or dealing in any manner with solicitation of individuals to fill jobs or positions for any private, commercial, industrial, group or entities. In addition, the Corporation may engage in any activities or business permitted under the law of the United State and the State of Florida.


