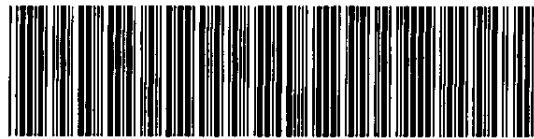

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

Effective Date *March 12, 2009*

ARTICLE I: NAME

The name of the corporation shall be: **MARICOPA ALTERNATIVE SOLUTIONS, INC.**

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 96147 Montego Bay, Fernandina Beach, Florida 32034.

ARTICLE III: EXISTENCE AND DURATION

This corporation shall exist perpetually commencing on March 12, 2009.

ARTICLE IV: PURPOSE

This corporation is organized with the general powers named in Chapter 607, Florida Statutes, currently in effect or as amended, to include but not limited to the right:
