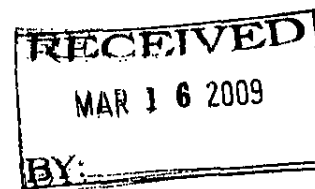

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby act as incorporator adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the Corporation is: Doug Prentiss, Inc.

**ARTICLE II**

The street address of the principal office of the Corporation is: 13409 NW 202<sup>nd</sup> Street, Alachua, FL 32615. The mailing address of the Corporation is the street address, given above.

**ARTICLE III**

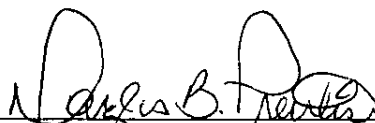
