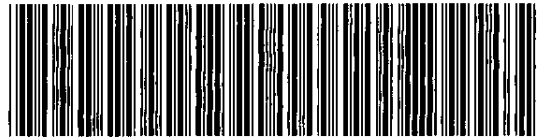

**ARTICLES OF INCORPORATION**  
**OF**

The undersigned, acting as incorporators of the corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation.

**ARTICLE I.**

The name of this corporation is

**CHIMIZA HANDBAGS OF COLUMBIA, INC.**

**ARTICLE II.**

The purpose for which this corporation is initially organized is for establishing and operating a retail networking sales, and for the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Florida. The address of the corporation is 519 13<sup>th</sup> Street West, Bradenton, FL 34205.

**ARTICLE III.**

The corporation shall have the authority to issue ONE HUNDRED shares of common stock having a par value of ONE dollar per share. There shall be only one class of shares.

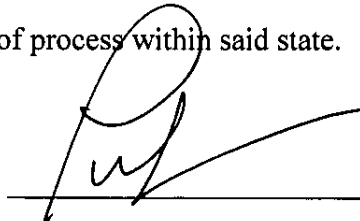

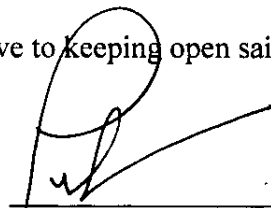
