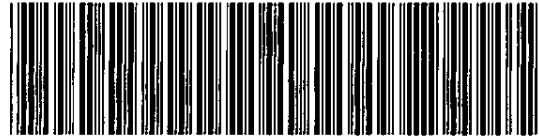

The undersigned incorporator hereby forms a for-profit corporation under Chapter 607 of the laws of the State of Florida.

**ARTICLE I. NAME**

The name of the corporation shall be 441 CENTRAL BILLIARDS, INC. The address of the principal office of this corporation shall be 441 Central Avenue, St. Petersburg, FL 33701, and the mailing address of the corporation shall be the same.

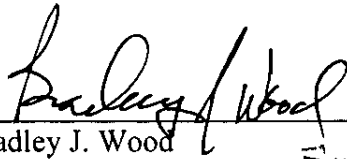

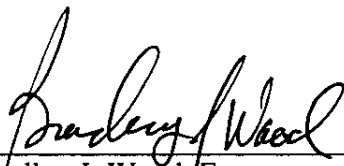
