

The undersigned, for the purpose of forming a corperation under the provisions of Chapter 607 of the Florida Statutes, adopts the following Articles of Incorporation:

ARTICLEI

The name and initial address of this corporation shall be FRANKY'S PIZZA & SUBS, INC., 225 SW 5 Street, Pompano Beach, FL 33060.

ARTICLE II

This corporation shall communes its existence immediately upon the filing of these Articles of Incorporation and shall exist perpetually thereafter unless somer dissolved according to law.

ARTICLE III

This corporation may engage or transact in any or all bewful activities or business permitted under the laws of the United States, the State of Florida or any other state, country territory or nation.
