The undersigned adopts the following Articles of Incorporation to form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be CPT Jewelers Corp.

ARTICLE II - COMMENCEMENT & DURATION

The corporation shall commence its existence on March 20, 2009 and shall exist perpetually unless sooner dissolved according to law.

ARTICLE III - ADDRESS

ARTICLE IV - STATED CAPITAL

The corporation is authorized to issue the following capital stock:


ARTICLE VIII - SHAREHOLDER PROPERTY


