## ARTICLES OF INCORPORATION

OF

#### ARTICLE I. NAME

#### ARTICLE III. PURPOSE

#### ARTICLE IV. AUTHORIZED SHARES

The maximum number of shares that the corporation is authorized to have outstanding at any time is 1,000 shares of common stock having a par value of \$1.00 per share. The consideration to be paid for each share shall be fixed by the board of directors and may be paid in whole or in part.
