ARTICLES OF INCORPORATION

OF

MICHELANGELO'S FURNITURE, INC.

ARTICLE I - NAME

The name of the corporation is Michelangelo's Furniture, Inc., at 2363 Emerson Drive SW, Palm Bay, FL 32909 (Principal Office of Registered Agent).

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida. $\Xi \omega$

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any of all lawful business

ARTICLE IV - CAPITAL STOCK
