### ARTICLE I Name and Duration

The name of the Corporation is accu-risk, Inc. The duration of the Corporation is perpetual. This Corporation shall begin its corporate existence as of the date that these Articles are filed by the Secretary of State.

### ARTICLE II Principal Office
