

The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following articles of incorporation:

#### **ARTICLE ONE**

The name of the corporation is ERIC R. FETT Builders, Inc.

#### **ARTICLE TWO**

#### **Corporate Duration**

The duration of the corporation is perpetual.

#### ARTICLE THREE

#### **Purpose or Purposes**

The general purposes for which the corporation is organized are:
