ARTICLES OF INCORPORATION

ARTICLE I- NAME

The name of this Corporation is Taino Express Freight, Inc.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares which this Corporation is authorized to have outstanding at any time is five hundred (500) shares of common stock without par value.

ARTICLE V - INCORPORATOR

ARTICLE VI - INITIAL REGISTERED OFFICE & AGENT

The initial registered office of this Corporation shall be 13110 S.W. 70th. Lane, Ocala, Florida and the initial registered agent of this Corporation at such office shall be Luis E. Pacheco, who upon accepting this designation agrees to comply with the provisions of Section 48.091, Florida Statutes as amended from time to time, with respect to keeping an office open for service of process.

ARTICLE VI – INITIAL BOARD OF DIRECTORS

The initial Board of Directors shall consist of three members.

The number of directors may be increased or decreased from time to time by vote of the stockholders, but in no case shall the number of directors be less than two nor more than four. The names and addresses of the directors constituting the initial Board of Directors are:

ARTICLE VII - AUTHORITY OF BOARD OF DIRECTORS

Any and all shares without par value, the consideration for which has been fixed by the Incorporator or by the Board of Directors and has been paid or delivered, shall be fully paid and non-assessable.

ARTICLE VIII – DIVIDENS

The Board of Directors are hereby authorized to fix and determine whether any and if any, what part of the surplus, however created or arising, shall be used, declared in dividends, or paid to shareholders, and without action by the shareholders, to use the surplus, or any part thereof, as is permitted by Corporate Law, for the purchase or acquisition of shares, voting trust certificates for shares, bonds, debentures, notes, script, warrants, obligations, evidences or indebtedness or other securities of the Corporation.

ARTICLE IX - STATED CAPITAL

The amount of capital with which the Corporation shall begin business is \$100.00 (one hundred).

ARTICLE X – AMENDMENT OF ARTICLES

The Corporation reserves the right at any time, and from time to time, to amend these Articles of Incorporation in the manner now or hereafter permitted by stature. Any change authorized by the holders of shares entitling them to exercise a number as may then be required by statute, shall be binding and conclusive on every shareholder of the Corporation as fully as if each shareholder had voted for the change. No shareholder, notwithstanding that he or she may have voted against the amendment or may have objected in writing, shall be entitled to payment of the fair case value of his or her shares or any other rights of a dissenting shareholder.
