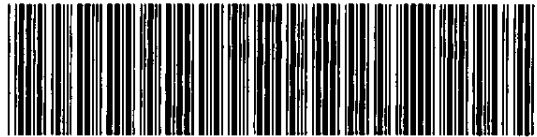

The undersigned for the purpose of forming a corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation.

Article I:

The name of this corporation is DMII, Inc, with its principal office located at 105 Alexandra Woods Dr. Debary, FL 32713

Article II:

This corporation shall have perpetual existence.

Article III:

The nature of the business to be transacted by this corporation is as follows.

- 1.) To transact any lawful business in the State of Florida
- 2.) To buy, sell, exchange real estate held by this corporation or to act as a broker for real estate transactions.
- 3.) To consolidate or merge with any other corporation
- 4.) To have a corporate seal
- 5.) To sell, convey, mortgage, lease, or otherwise acquire, own, improve, hold, use or otherwise deal with its property or assets.
- 6.) To make contracts and guarantees and incur liabilities, borrow monies, issue notes, bonds, or other obligations by mortgage or pledge of all or any of its property.
- 7.) To have and exercise all powers necessary or convenient to effect its purpose.
- 8.) To have all of the rights and privileges of corporations for profit as conferred by the laws of the State of Florida.
- 9.) To act as a licensed general contractor in accordance with Florida State laws.

Article IV:



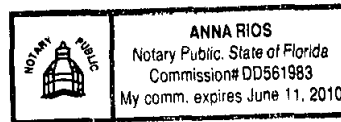
