THE UNDERSIGNED, FOR THE PURPOSE OF FORMING A CORPORATION UNDER THE FLORIDA GENERAL CORPORATION ACT, HEREBY ADOPTS THE FOLLOWING ARTICLES OF INCORPORATION:

# **ARTICLE I. NAME**

THE NAME OF THIS CORPORATION IS ANDREA KNUDSEN, INC.

## **ARTICLE II. PRINCIPAL PLACE OF BUSINESS**
