Of

(A Corporation for Profit)

The undersigned incorporator of these Articles of Incorporation, a natural person competent to contract, hereby form a corporation pursuant to the Chapter 621 Florida Statutes, laws of the State of Florida and do hereby adopt the following Articles of Incorporation.

ARTICLE I

NAME

The name of the corporation is **THE EDGE AT YBOR, P. A.** This corporation is to exist perpetually.

ARTICLE II

GENERAL PURPOSES

The general business to be transacted and the purpose for which the corporation is formed are:

1. To operate as a company primarily engaged in the business of providing cosmetologist services and other related professional services to the general public.

To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can in the opinion of the Board of Directors of the corporation, be advantageously carried on in connection with, or auxiliary to the foregoing business.

2. 
